### Mendlesham Community Centre Charity

An Annual General meeting of Mendlesham Community Centre Charity was held at the Old School Room, Mendlesham, Wednesday 17 May 2023 at 7.19pm.

**Present:** Cllrs A Davey, P Allen, M Exley, D Foster, N Foster, S Judd, D Lummis, H Orton, E Ward, S Jones (Clerk) and three members of the public.

**Apologies:** Cllr C Orton ( personal reasons). This was accepted by the Charity.

The filming statement was read out.

### 2. Declarations of interest:

a) To note Councillor's declarations of interest in any of the following agenda items.Cllrs D and N Foster declared a Registrable interest in agenda items 9 relating to the sale and new building project of Mendlesham Community Centre, as their property may be affected financially or their wellbeing affected.

b) To agree any dispensations with regard to declarations of interest. Not required.

#### 3. Minutes:

a) It was noted that the minutes of Annual General Meeting held on 11 May 2022 were approved at the Charity meeting of 8.6.22.

b) To approve minutes of Ordinary Meeting of 15 March 2023. Pages 429-431 inclusive were unanimously approved for accuracy, signed and dated by the Chairperson.

### 4.Annual Reports:

### a) Chairs report:

Our project to take advantage of the unique opportunity to sell the existing building, securing continued use of the Main Hall and Changing Rooms for community hire for the future, and then build a new hall which will be financially and environmentally sustainable and provide modern facilities for the community, available during school times, for the next thirty or so years continues.

There has been some progress in the last year. Much of the year has been spent negotiating with Fields in Trust, for them to agree to release their deed of dedication over the Community Centre Charity building so that it can then be sold to Suffolk County Council. We have also requested permission to build a new building on land owned by Mendlesham Memorial Playingfields Charity. A direct response re the new build has not been received, although our interpretation, to be confirmed by legal opinion, is that the new project falls within Field in Trust Policies. A public consultation was held from 1.2.23- 31.3.23, followed by a public vote in April 2023 to confirm in preparation for an application to the Charity Commision to :

- a) Merge both charities
- b) Sell Mendlesham Community Centre owned parts of the existing building.

Hire of the existing building is managed by the John Milton Academy Trust, pending sale.

# b) Financial report, to include accounts for the year ending 31.3.23 noting inventory requirement has been suspended due to anticipated sale.

The year end 31.3.23 shows receipts of  $\pounds$ 5,815.86 ( $\pounds$ 14,169.11), hire income for the SEND unit pending sale and MSDC Recycling Credits for the Bottle Bank at Mendlesham Kings Head PH (with thanks to Cllr Allen).

Payments of £5,256.11 (£7,644.98) include legal fees £2647, to advise on the way for a new build following sale, repair and replacements for the existing building £576 and administration and audit fees.

Funds are held in a current account  $\pounds 6,162.28$  and deposit account  $\pounds 28,194.95$ .

**c) To note insurance arrangements:** noted as included as part of policy held in the name of Mendlesham Parish Council.

**d)** To confirm the schedule of direct debits and standing orders. All direct debits and standing orders have been cancelled pending sale of the building.

e) To confirm payment of invoices where required online in accordance with Mendlesham Parish Council financial standing orders and agreed process. Unanimously confirmed.

**f) To confirm bank signatories.** Cllrs Davey, H Orton and Sharon Jones, plus the addition of Cllr Allen and Cllr Ward and the removal of David Nunn and Madeline Watson was unanimously confirmed. Any two to sign, to include use of online banking.

### Sale of Mendlesham Community Centre and New Build.

### **Proposal B:**

Mendlesham Community Centre (registered charity number 304795) proposes to sell Mendlesham Community Centre building and pavements..... by way of freehold transfer to Suffolk County Council. The land has not been advertised in the open market but the trustees have sought and followed the written advice of a surveyor, in accordance with their duties under Part 7 of the Charities Act 2011. The Mendlesham Community Centre charity intends to use the proceeds of the proposed sale towards funding a new community centre in the Parish.
